

# **Children and Youth Parent Manual**

Calvary Episcopal Church's mission is making God's love visible in downtown Memphis. We encourage our children and youth to live into this mission as part of a safe and loving community. Contained within this manual, you will find information regarding the Children Ministry and the Youth Ministry's guidelines, procedures, and code of conduct. The guidelines and procedures are in place to provide safety for all children and youth. Please take the time to read this manual and discuss it with your child. Expectations of parents/guardians, children, youth, and Calvary staff are outlined. Parents/guardians, children, youth, and Calvary staff are responsible for the information contained in this manual. Questions can be directed to the director of children and family ministries and/or the director of youth ministries, or a member of the clergy.

#### **Ministry Structure**

Calvary Episcopal Church Children and Youth Ministries seek to build meaningful spiritual formation opportunities through religious education, worship, service, events, and activities for Calvary parishioners age 0 to 18.

## **Children's Chapel**

Children's Chapel is an opportunity for children to experience the "Liturgy of the Word" in an easy to understand, story-based format. The liturgy is geared for children age three to seven. Near the beginning of the 10 a.m. worship service, children follow the children's cross bearer out of the Nave to Children's Chapel, located in Room 203 of the second floor education wing.

## **Sunday Formation**

Formation classes (Sunday School) for children are held year-round from 11:15 a.m. to 12:15 p.m. Youth Sunday formation (Sunday school) is held year-round from 11:30 a.m. to 12:15 p.m. During the regular school year (August-May) formation classes are divided by grade level. During the summer months (June-July) formation classes are in larger groups.

## **Nursery Care**

Calvary maintains a nursery facility located in the Calvary Place Child Care Center and in the Orgill Room for children ages six weeks to five years. The nursery is staffed by trained, professional caregivers. The nursery is open on Sundays from 8 a.m. to 12:30 p.m. and on Wednesday nights from 5:30 to 7:30 p.m. A Child Registration form must be completed and all children must have up-to-date immunizations in order for a child to attend the nursery.

## Wednesday Evenings

Calvary's Wednesday evening programing includes dinner, classes, and choir rehearsals during the fall, winter, and spring months. The Calvary Nursery is open from 5:30-7:30 p.m. in the Orgill Room for

children ages six weeks to five years of age. Calvary's children's choirs, children's classes, and Episcopal Youth Community (EYC) meet from 6:15 to 7:15 p.m.

## Sunday Night EYC

Calvary youth ministry offers Sunday Night EYC from 5 to 7 p.m. for high school students. Location of Sunday Night EYC varies and students and parents will be given advanced notice of the Sunday evening location.

#### **Child Registration Forms**

Parents/guardians should complete a Child Registration Form for each child at the beginning of the school year. The program director will distribute and maintain forms. If any information changes during the school year, it is the parent/guardian's responsibility to inform the program director.

#### **Permission Forms**

Events and activities held outside of the walls of Calvary may require individual permission forms. Permission forms will be made available and distributed to parents/guardians in a timely manner by program staff. It is the parent/guardian's responsibility to complete individual permission forms.

#### **Parent Involvement**

Parent involvement is essential to maintain successful Children and Youth Ministries programs at Calvary. It is important to keep in touch with the program staff, formation teachers, and event chaperones while your child participates in the program. Parents are strongly urged to volunteer their talents of teaching, leading, chaperoning, event planning, and event execution.

#### **Drop Off and Pick Up**

Please be mindful of our staff's and volunteers' commitment to teach, lead, chaperone, and care for Calvary's children and youth. Please respect designated drop off and pick up times for your child at the designated location(s). If an adult other than their parent/guardian is responsible for picking up your child, please inform the program staff and/or program volunteer. Children under the age of 10 should be picked up from Sunday formation class by their parent/guardian or a designated adult. Children who attend the nursery must be signed in and out and picked up by their parent/guardian or designated adult.

#### **Illness Procedure**

Calvary is concerned for the health of each child. Your child must be picked up as soon as possible if your child becomes ill. In case of an emergency, parents will be contacted using the information provided on the Child Registration Form.

#### Medication

Calvary's program staff asks that parents/guardians administer medication to their children at home. Program volunteers may not administer medication to a child. Program staff may only administer medication to a child if the parent/guardian has given expressed permission each time.

## **Children with Special Needs**

Calvary Children and Youth Ministries strive to meet the needs of every child. In order to assist us in meeting your child's needs it is important that you complete the Child Registration Form in detail. We will do our absolute best to accommodate all children at Calvary; however, children are required to refrain from behaviors that threaten the safety of themselves, other children, volunteers, and staff members.

#### **Confiscated Items**

From time to time, children bring items with them to activities and events. These items include toys, books, and electronic devices. Sometimes these items create a distraction for the child as well as other participants. These items may be collected by program staff or volunteers and remain with the staff member or volunteer until the activity is over.

#### **Children and Youth Ministries Code of Conduct**

Calvary children and youth are expected to be respectful of their peers, church staff, volunteers, Calvary, and Calvary's property, as well as the property of others at all times. The Code of Conduct is intended to assist students in governing their own behavior. The guidelines and procedures contained within the code of conduct are necessary to help ensure a safe environment for all children and youth. We request that you familiarize yourself with Calvary's code of conduct and discuss the importance of this code with your children.

#### Discipline

Calvary is committed to positive behavior management and expects children to be responsible members of the church. Each child is expected to uphold Calvary's code of conduct. Discipline will be reasonable, understandable, and appropriate to each child. Praise and encouragement of good behavior is used. If a problem occurs, you will be informed. Parents/guardians are expected to work with the program staff to resolve any problems.

#### **Children's Ministry Policy**

During Sunday and Wednesday formation or a Calvary children or youth event, if a teacher or volunteer believes a child is acting disrespectful or disruptive to the class, teachers, volunteers, or other students, he/she will inform the child that they have three (3) chances to improve their behavior before being escorted to their parent/guardian. If child continues to be disrespectful or disruptive and the teacher, leader, or volunteer in charge has already escorted the child to their parent/guardian two (2) times in the past, then the program director or clergy will ask the parent/guardian to accompany the child to class or the event the next time they attend.

## Youth Ministry Policy

During Sunday Formation, EYC, and other youth events, if a leader believes the youth is acting disrespectfully to the class, teachers, volunteers, or other students, the youth will be given the choice to leave and find their parents or stay and change their behavior. If disrespectful behavior continues, the youth will be told to leave to find their parents if available or call their parents for immediate pick-up.

## **Disciplinary Plan**

Children with continual behavior problems and or disciplinary problems during formation time or children and/or youth events will be asked to create a disciplinary plan with their parents and members of Calvary staff. This plan may include loss of privileges to attend children and/or youth activities outside the walls of Calvary. Behavior that warrants a disciplinary plan includes but is not limited to:

- 1. Behavior that negatively affects the safety of others, such as the use of force, hitting, or physical or verbal intimidation.
- 2. Open or continued defiant attitude or willful disobedience toward a church staff member or program volunteer.
- 3. Threatening bodily harm to another person.
- 4. Fighting.
- 5. Sexual or racial and ethnic harassment.
- 6. Bullying and harassment.
- 7. Verbal abuse, use of profane language, obscene gestures, or written obscenities.
- 8. Any illegal activity.

# Parent's Rights

Parents have the right to

- know their children are in a safe environment where their social, emotional, and spiritual health is being fostered;
- know what types of programs and activities are administered and share concerns with staff, at any time, about anything they do not fee is in the best interest of the child;
- know if their child is misbehaving and spend time working with the program staff to resolve unacceptable behavior;

voice special concerns not covered within this manual.

# Parent's Responsibilities

Children and youth should be supervised at all times. Parents are responsible for

- observing the rules of this program as set forth in this manual as well as any additional guidelines, procedures, or individual event permission forms;
- replacing any equipment or property their child has misused or destroyed;
- signing their child in and out of activities when necessary;
- notifying program staff or volunteers when taking a child from the activity;
- notifying program staff or volunteers when another person is authorized to pick up their child from an activity and/or event;
- picking up their child on time;
- maintaining a current child registration form with the program director.

# **Children's Rights**

Children have the right

for their ideas and feelings to be respected;

to discipline that is fair, equal, and not harmful to their self-esteem;

to express creative ability, anger, frustration, disappointment, and joy in an appropriate manner; to a safe environment free of hazards.

#### **Children's Responsibilities**

Children are responsible for

- respecting the rules that guide them and controlling their feelings such that their actions do not harm anyone in the program;
- remaining with a program staff member or volunteer at all times;
- respecting the rules of the program and taking care of the church space, equipment, and property.

#### **Transportation and Youth**

A licensed young person may, with their parent's permission, drive to and from a Calvary Episcopal Youth Community (EYC) event. Young people, with the permission of all parents/guardians concerned, may bring other young people to events. They must also take the same young people from the event. Event leaders must receive written or oral parental permission before allowing young people to leave with a youth other than the youth that brought them to the event. No youth may drive during any youth event.

#### **Cell Phones**

Youth with phones are asked to respectfully silence and put away their phones during formation and youth events, unless instructed otherwise. Youth with phones are asked to step out of the room to take phone calls and to use discretion when sending messages to parents. If a leader believes the cell phone is distracting to the group, they may ask the youth to put the phone away for the remainder of the class or event.

#### Volunteers

People who volunteer with children and youth, ages 0-18, must abide by The Diocese of West Tennessee Policy on Protection of Children and Youth from Abuse as found on the Diocesan website at <u>episwtn.org</u>.
