 of Calvary for last 20 years . . . need to know perspectives of all in the room . . .
 - Kathryn can offer variety of thoughts on various topics; Welcome Ministry a focus
 on how we welcome ourselves back to Calvary
 - Jerry understanding of accessibility issues
 - Greta new perspectives as a fairly new member of Calvary . . . need patience from the group not only because I'm new, but because I'll offer the weird perspectives . . . very interested in congregational mix from a variety of perspectives: race, age, and more . . . very active in Basement Church and believe it can offer much to overall Calvary picture
 - Scott pretty good instincts even though I'm not a long-time member; can help us pivot; nothing bigger for Christian than racial justice, but in this year, I think Welcoming people back and those who come here for the first time
 - Paul 5.5 years . . . pastoral care focus . . . need reminders from parishioners to call or reach out to others . . . racial diversity and
 - Madge Calvary "lifer" . . . not interested in doing things "because we've always done them this way", but can sometimes offer perspective on "the why" behind certain activities / traditions; like to approach projects from a "begin with the end in mind" perspective
 - David lawyer helping people with financial and legal problems; experiences with non-profit boards... racial diversity is important to me personally – raised our African-American child and grandchild in Chickasaw Gardens... Have been the lawyer for Harold Ford Funeral Homes for 25 years
 - John am more of a "doer" than a deep thinker . . . need communication reminders . . .
 I think we're going to do the Welcoming Back as naturally as we breathe . . . Am interested in Racial Diversity

- James HR and Grant-Writing experience . . . Need to be able to converse with people to get a variety of opinions . . . Focus on downtown demographics . . . Need to be a bridge that brings downtowners to us - Important for the growth of Calvary . . . Like John, I'm a doer!
- Anna Kathryn much involvement in community worker am able to see the big picture of projects
- Nancy Am able to talk with people of all backgrounds and ages . . . Anxious for us as a Vestry to focus on Capital Campaign
- Zach communications is key must be open and honest . . . Board development is one
 of my strengths. . . How do we become the kingdom of God HERE?
- Bailey excited about coming back to Calvary and helping people find Calvary as their church home . . . In a post-COVID world, people are looking for community after a year of solitude
- Elizabeth organizational skills are a strength . . . key focus on Calvary motto of Making God's Love Visible in Downtown Memphis

Kat – purpose of this exercise was to ensure we all know what we bring to the table as individuals and as a group . . .

Important for us to not just create "to do lists" but to identify all that needs to be done to accomplish our goals, and to flush out what does not need to be done.

NORMS – a verb - what are the things that happen to make someone realize they belong here

7:02 pm . . . Activity – getting in groups of three or four . . . assign a spokesperson . . . assignment sheet . . . discuss what the person on the assignment sheet experiences as they come here . . . what actions can we identify that start immediately without waiting for a Capital Campaign . . . Can approach assignment with Calvary of Today or of the Future . . . No more than 15 minutes for the exercise . . . Do the exercise assuming you're entering the building through an entrance you don't normally use . . .

- Laura all guests found informative brochures as helpful; were nervous about exactly what to do when
- **AK** a dyslexic guest wondered how she can learn about Calvary and Episcopalian traditions since she has trouble reading . . . all other guests had trouble navigating the halls and finding their way, with the exception of Timmy, the 3rd grader who loved exploring
- Kathryn various characters entered through the awning doorway . . . talked about the need for a formal greeter at that door to help people find their ways . . . both signage and lighting are weak . . . must be sensitive to how people like to be greeted (not all are comfortable with a beeline greeter! Discussions of low-key ways for a newcomer to find their way)
- **Lisa** one guest came to Calvary via online services; one with elderly mother; one was the guest speaker; one was a cradle Calvary-ite . . . discussions of accessibility for the elderly mother . . . again, signage and lighting are not strong, this time discussed from the Second Street entrance, by Montgomery Foyer . . . People are welcoming, but the space is not necessarily so

How many moved through the actual newcomer path during the exercise? About half...

Homework... move through the campus using a new person's eyes (your character in the exercise) and use a Calvary member's eyes, remembering everyone has been away for a year... Remember, some are going to be eager for hugs, and some are going to be terrified to be touched and by close

contact... How are we guiding folks through various comfort levels... Use an entrance you don't normally use... Also, look at the website and consider it as a point of entrance... We, as the Vestry, can play a key role in noticing the places and things that might be stumbling points for others, and what might we do to correct that
