Financials Posted to Realm

- 1) Performance vs budget on a year-to-date basis is more or less on track; only a couple expense items are looking a little heavy. Kitchen expenses are running a little high, likely a combination of both greater volume and higher prices
- 2) Seems to have been a return to normal seasonal patterns with softer pledge collections in June. No cause for concern at this time as we're still on track year to date.
- 3) The term sheet process for the construction loan is going well. We are going back to First Horizon to see if we can get slightly better terms their interest rate and security requirements were materially less attractive than the other proposals we've received to date.

Construction Process Overview and Updates

- Church construction begins this week, and communications / pictures will be shared with the congregation
- Discussion of restroom options once construction begins on the rest of the building
- Question asked about earthquake insurance . . . Details will be coming soon and discussion will follow . .
 Holy Communion opted to not include earthquake insurance because of the high deductibles and expense

Construction Loan Overview

Detailed overview of terms and conditions associated with loan applications from four banks. There are pros and cons of each offer. First Horizon is our long-term banking partner, and yet theirs is the least attractive offer of the four! ... Pinnacle wants us to move our deposits to their bank if we go with them for the loan ... Erik offered a "50,000 foot overview" of the four proposals ... Will be posting a summary of the four offers to Realm ... We're hoping to get more attractive terms from First Horizon because of the long-term relationship and because we deal with them on a daily basis for "routine church business".

Additional Discussion Topics:

- Franklin brought up how well the Great Hall services are going! 165 chairs in place. . . Katherine encouraged early arrivers to sit on the choir side so late arrivers can sit on the east side of the Great Hall.
- Scott encouraged Vestry members to try the 6pm service. Current attendance is averaging 15 35.
- Clay asked about pew repairs - they will be repaired and refinished . . . there will be new cushions
